

"More than 20 years ago, as a United States Senator representing the state of Colorado, I introduced ground breaking legislation that resulted in the establishment of the Sand Creek Massacre National Historic Site to memorialize one of the most disgraceful moments in American history while honoring the Cheyenne and Arapaho people, mostly women and children, who lost their lives on November 29, 1864. As a Cheyenne descendent of the massacre, this exceptional effort was as personal to me as it was significant to the Cheyenne and Arapaho people and the nation as a whole. I have been very gratified to see how the national historic site has developed and the public awareness of the Sand Creek Massacre that has grown as a result.

Today, I am proud to serve as the Honorary Chairman of the Board of the Sand Creek Massacre Foundation, a 501(c)3 nonprofit organization created to support the national historic site's educational programs and the development of the Center for Sand Creek Massacre Studies. Although the Foundation is new, much has been accomplished in its first year. The Sand Creek Massacre Foundation is dedicated to raising awareness of the history and present day implications of the Sand Creek Massacre.

Established in February 2020, the Sand Creek Massacre Foundation is a newly formed 501(c)3 nonprofit organization. During 2020, thanks to the work of the Foundation Development Committee (who met February 2018 to February 2020) and the partially-seated Board of Directors (who met 22 times), the Foundation:

- Built organizational capacity to ensure a strong financial and legal infrastructure
- Generated momentum for the Sand Creek Massacre Foundation's mission
